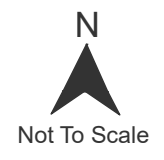

Adams Ave Closed east of Tuolumne

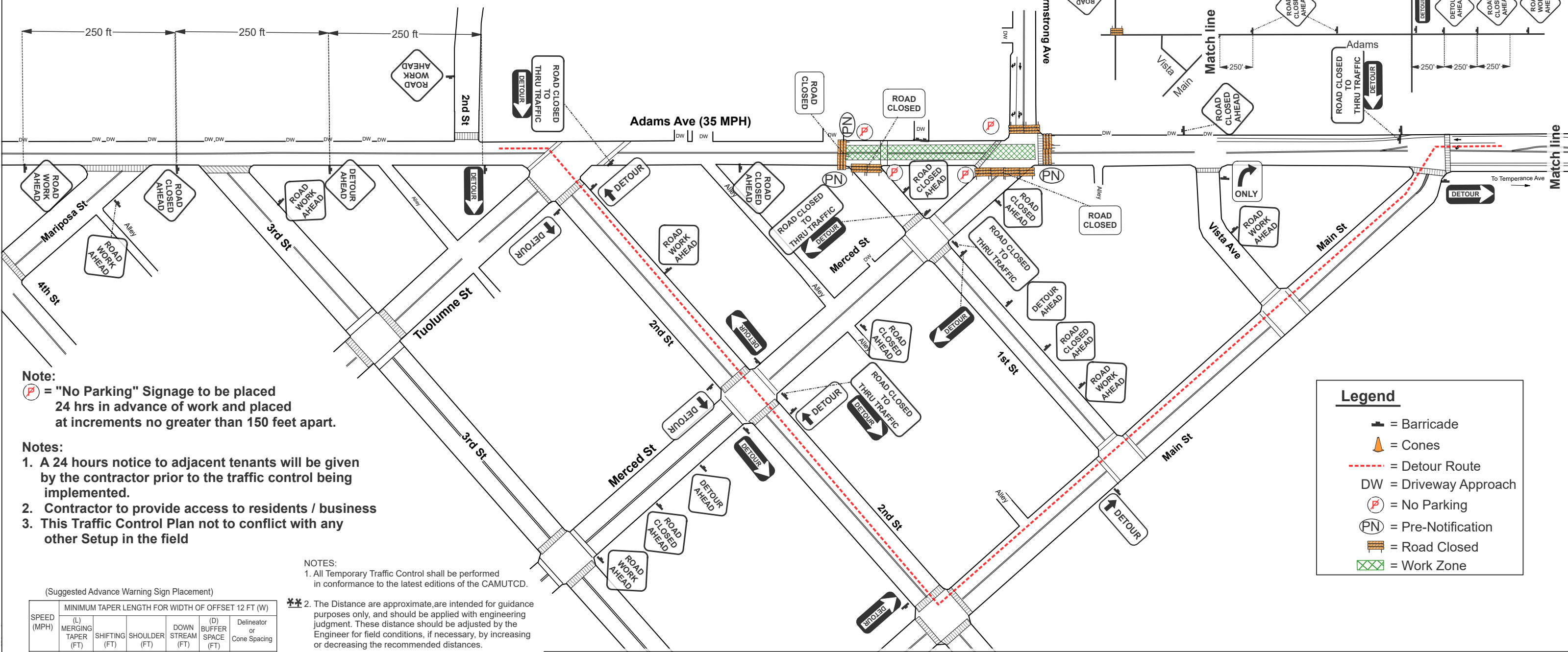

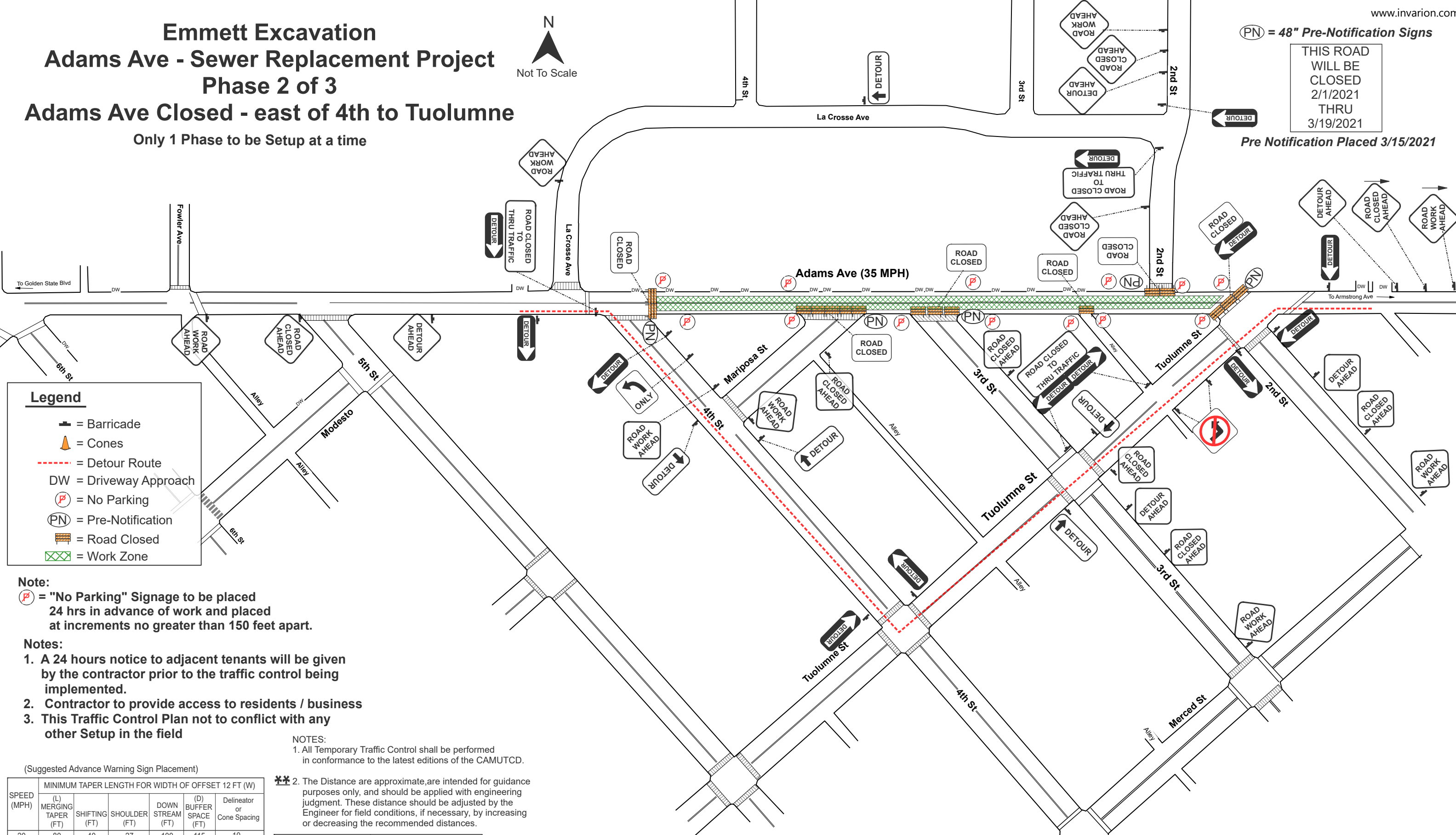

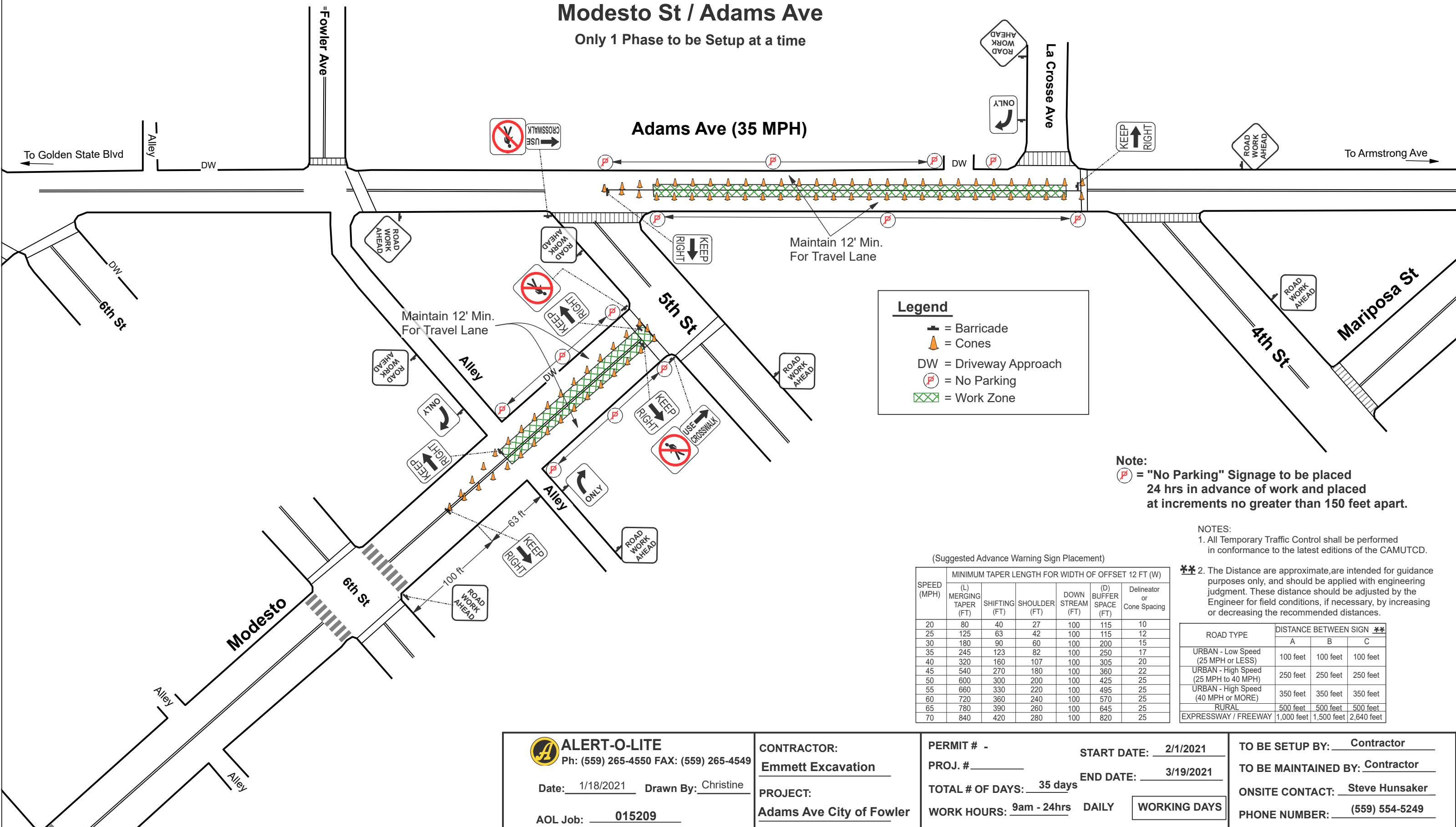

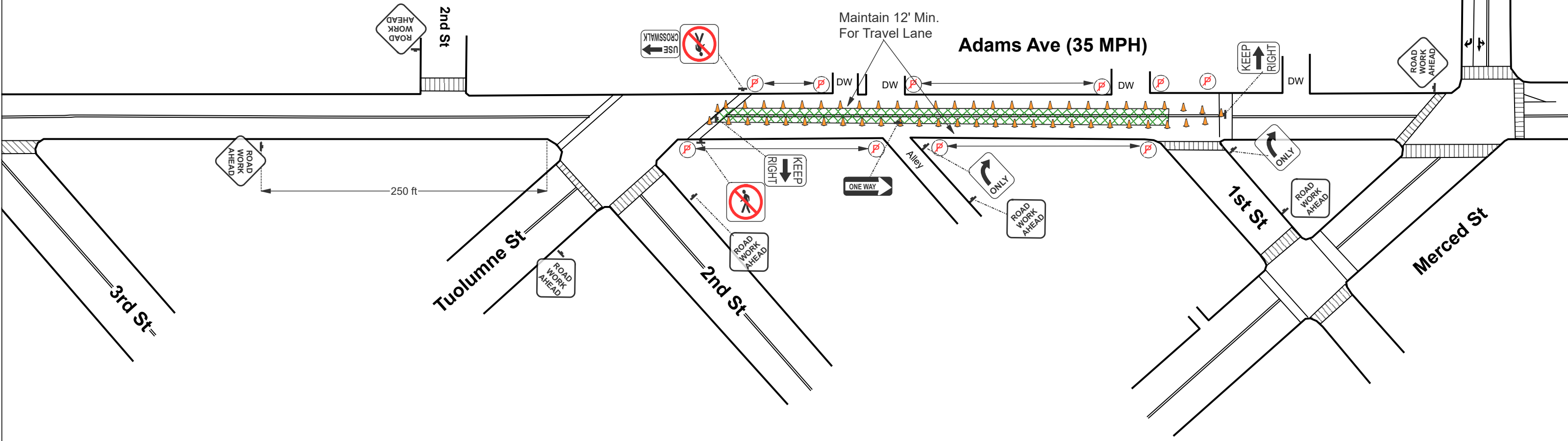
