## MEETING MINUTES CITY OF FOWLER RECREATION COMMISSION

# CITY COUNCIL CHAMBERS 128 SOUTH 5<sup>TH</sup> STREET, FOWLER CA. 93625 OCTOBER 12, 2021

Pursuant of section 2-2.206 of the City of Fowler Code of Ordnances, the Recreation Commission shall hold meetings at least once each month, at a time and place set by resolution, and shall adopt rules for the conduct of business and shall instruct the secretary to keep accurate record of its minutes, resolutions, transactions, and other business.

Such records shall be a public record and shall be maintained in the office of the City Clerk.

All meetings shall be open to the public and shall abide by the provisions of the Ralph M. Brown Act. A majority of the Commission shall constitute a quorum for the conduct of business. (Ord. 78-1, 4-5-78)

Pursuant to the notice of meeting duly given, a meeting of the City of Fowler Recreation Commission was held on Tuesday, October 12, 2021, at 6:00 p.m. in person at the City of Fowler City Council Chambers located at 128 South  $5^{th}$  Street, Fowler, Ca. 93625.

Chairman Patric Jones called the meeting to order at 6:01pm

Upon completion of roll call a quorum was established based on the following attendance:

#### PUBLIC PRESENTATIONS

There being no presentations from the public in person or via the teleconference, this portion of the meeting was concluded.

#### APPROVAL OF THE MINUTES

Chairman Jones asked if there are any additions or corrections to the minutes of the September 14, 2021 Recreation Commission Meeting. There being no further additions, and upon motion by Chairman Jones and second by Commissioner Alvarez, the following resolution was approved unanimously.

RESOLVED, that the Commission hereby approves the minutes of the September 14, 2021 City of Fowler Recreation Commission meeting.

#### COMMISSION REPORTS

Chairman Jones continued the discussion on the option of adding a standing line item to the agenda titled "Commissioner Reports" which would allow for each member of the Commission to provide updates, developments, or event ideas. Discussion ensued resulting in the unanimous approval of the following resolution made by Commissioner Alvarez and seconded by Commissioner Mejia.

RESOLVED, that the Commission hereby approves the addition of Commissioner Reports to the monthly agenda.

#### FALL FEST - CITYVVIDE YARD SALE RECAP

Chairman Jones and Recreation Department Coordinator, Hernandez reported on the recent City of Fowler Fall Fest event from Saturday, September 15<sup>th</sup>. It was reported that the event participation was not as high as previous years likely due to the pandemic and other conflicting events taking place in the valley. The Commission would prefer to go back to Spring Fest in March of 2022. Yvonne reported that vendors were pleased with the sales of that day but prefer for items to be donated to the Salvation Army at the end instead of thrown away to Waste Management.

#### TRUNK OR TREAT

Hernandez presented the 2021 walk-through Trunk or Treat event details slated to run along Merced street. The event would consist of approximately 30 cars passing out candy to residents. The Public Works team is working with Hernandez to block of streets beginning at 2:45pm on October 27th. Trunk or Treat cars can set up and decorate at 3:00pm and are required to stay until 7:00pm. The event would include a maze, food vendors, craft vendors, music and karaoke. Hernandez recommended that cars purchase a minimum of 2,000 pieces of candy per car and informed the Commission that they must purchase their own candy if they plan to have a car in the line. Commissioner responsibilities were assigned accordingly at the entrance of the event to assist with traffic flow and to assist with setting up the maze – all Commissioners should arrive at the event at 2:45pm. Hernandez also reported that the Police Association in partnership with the Fowler Lion's Club, donated funds to help provide the maze experience to the community. Additional discussion ensued regarding the straw maze compared to the inflatable option.

Councilman Mejia reported on the response from legal council on the use of ownership of an inflatable corn maze as a follow-up from the previous Commission meeting.

Upon further discussion, the Commission approved the inflatable maze with recognition to the Fowler Lions Club and the Police Association for their monetary contribution to ensure the maze was provided to the community.

Commissioner Parker informed the Commission that he would not be present for the Trunk or Treat event.

#### CHRISTMAS TREE LIGHTING CEREMONY

Chairman Jones recapped the attractions slated for the event and asked the Commission to present ideas to contribute to the Christmas Tree Lighting experience in light of the donation made by Councilman and Commissioner Mejia of the Live Reindeer Petting Zoo and Trackless Train Ride. Commissioner Mejia recommended additional attraction options for consideration. Hernandez challenged the commission to bring new ideas to make the event extra special as a follow-up from her original request at the September Commission meeting. It was recommended that the Trackless Train Ride be adopted by the Recreation Commission instead of donated and paid for from the allotted budget. Upon the close of the discussion and upon motion by Chairman Jones and second by Commissioner Parker, the following resolution was approved unanimously.

RESOLVED, that the Commission hereby approves the Trackless Train Ride to be sponsored and paid for by the City of Fowler Recreation Commission.

Commissioner Mejia presented ornaments for consideration for the main street Christmas tree. Guidelines, supply lists, instruction videos and additional details were discussed. Discussion ensued regarding the preferences surrounding each ornament and the positive feedback provided by City Works regarding the logistics of each piece. Upon the close of the discussion and upon motion by Chairman Jones and second by Commissioner Parker, the following resolution was approved unanimously.

RESOLVED, that the Commission hereby approves the small bell, bow, and ball ornaments for the City of Fowler Christmas tree.

Chairman Jones reminded the Commission that Dr. Jimenez was the guest of honor scheduled to light the tree. There were no objections from the Commission.

#### CHILDREN'S SHOPPING DAY

Chairman Jones lead a discussion on the plan to purchase supplies and gifts for the Children's Shopping Day on December 11th from 11:00am to 3:00pm. Hernandez would be responsible for shopping ahead of time. Hernandez requested that the Commission be present to wrap gifts at the Senior Center at 9:30am the morning of the event.

### NEW AGENDA ITEMS TO BE ADDED FOR NEXT MEETING & COMMISSIONER REPORTS AND COMMENTS

Chairman Jones requested that a cook-off type event be considered. Discussion ensued regarding rules and restrictions associated with selling, tasting, or judging entrees. Hernandez would check with Fresno Health Department guidelines and report back at the next meeting.

Commissioner Alatorre requested that a Dog Show event or Halloween costume dog show be considered. This could be part of the Trunk or Treat event in 2022 as well as a potential costume contest for kids as well.

#### **BUDGET UPDATE**

Hernandez briefly reported that the payment for the 2022 fireworks show would be \$18k for an 18-minute show. This would be a one-year contract.

#### **OTHER MATTERS**

Chairman Jones reported that the next Recreation Commission meeting was scheduled for Tuesday, November 9, 2021.

#### **ADJOURNMENT**

A motion was made by Commissioner Parker and seconded by Commissioner Alvarez to adjourn the meeting which was concluded at 7:46pm.
