MEETING MINUTES CITY OF FOWLER RECREATION COMMISSION

CITY COUNCIL CHAMBERS 128 SOUTH 5TH STREET, FOWLER CA. 93625 JUNE 14, 2022

Pursuant of section 2-2.206 of the City of Fowler Code of Ordnances, the Recreation Commission shall hold meetings at least once each month, at a time and place set by resolution, and shall adopt rules for the conduct of business and shall instruct the secretary to keep accurate record of its minutes, resolutions, transactions, and other business.

Such records shall be a public record and shall be maintained in the office of the City Clerk.

All meetings shall be open to the public and shall abide by the provisions of the Ralph M. Brown Act. A majority of the Commission shall constitute a quorum for the conduct of business. (Ord. 78-1, 4-5-78)

Pursuant to the notice of meeting duly given, a meeting of the City of Fowler Recreation Commission was held on Tuesday, June 14, 2022, at 6:00 p.m. in person at the City of Fowler City Council Chambers located at 128 South 5^{th} Street, Fowler, Ca. 93625.

Chairman Jones called the meeting to order at 6:04pm.

PUBLIC PRESENTATIONS

Chairman Jones called for public presentations. There being no presentations from the public in person or via the teleconference, this portion of the meeting was concluded.

APPROVAL OF THE MINUTES

Chairman Jones asked if there are any additions or corrections to the minutes of the May 10, 2022 Recreation Commission Meeting. There being no further additions, and upon motion by Commissioner Rico-Vasquez and second by Commissioner Parker, the following resolution was approved unanimously.

RESOLVED, that the Commission hereby approves the minutes of the May 10, 2022 City of Fowler Recreation Commission meeting.

MONTHLY BUDGET REPORT

Coordinator Hernandez gave the monthly budget report stating that we began this fiscal year with \$36,000 dollars and have a remaining balance of \$248.00. Chairman Jones asked if tips will still be collected for the bands at the farmer's market, Coordinator Hernandez responded that she still intends to continue that tradition.

VETERANS DAY FUN RUN

Chairman Jones requested that Coordinator Hernandez re-report on the Fun Run scheduled for November 11, 2022. She reported that her recommendation is for alternate sponsors and partners support this effort instead of the City of Fowler. Commissioner Rico-Vasquez mentioned her interest in partnering. Chairman Jones suggested that Commissions volunteer if available. Commissioner Mejia committed to donating raisins for the runners since she works that day. Coordinator Hernandez suggested the Commission also assist with securing other sponsors or setup a water station.

PHAROAH'S CAR CLUB

Chairman Jones requested a recap on the car club event and Coordinator Hernandez provided additional insight informing Chairman Jones that no funds from the Rec Commission would be designated to support the car club event and that restrooms would be provided at no cost.

Public comment was made by resident Steve Barela stating that although the car club is a great show and their scholarships help our community, the Commission needs to be fair in their dealings with outside organizations. Coordinator Hernandez stated that providing restrooms was a service we could provide for any event within the community upon request.

FABULOUS 4TH OF JULY FIREWORK SHOW

Coordinator Hernandez and Commissioner Mejia recapped the upcoming event highlighting the following elements:

- Band named 4-Play has been secured and will perform from 6:30pm to dusk.
- New sound engineer booked for the event.
- New banner is up on Merced Street.
- Commissioners' arrival is at 8am. Commissioners can bring friends or family members that are willing to assist with setup. Once decorating is complete Commissioners are excused to return to the stadium at 4:30PM.
- Gates will open to the public at 5:30PM.
- Signage will be added along the fence stating "no ice chests permitted" advertise on social media as well.
- Pyrotechnician is also ready to go, and they have a special firework in the shape of 150 in honor of the sesquicentennial. This is a ground show visible by everyone attending the event in the stadium.

Commissioner Mejia reported that the VIP lounge has been cancelled this year.

Coordinator Hernandez reported that she is still looking for a group to manage parking for the event and that the snack bar would be managed by the Sesquicentennial Committee.

Coordinator Hernandez reported on the Commissioner job duties. Decorating would begin at 8am. The Public Works team would set out the waste bins. Coordinator Hernandez would provide the volunteer waiver for anyone who would be on site to help. Commissioner Rico-Vasquez offered to manage the volunteers for the event.

Two Commissioners would be stationed at the gate for the first 2-hour shifts, and another two Commissioners will relieve them for the second shift.

FARMERS MARKET

Chairman Jones asked for an update on the Fowler Farmers Market. Coordinator Hernandez reported that we are ready to kick-off the first market which is themed "Heroes Night" additionally cosplay superheroes would be present. Line Dance night on August 31st. Coordinator Hernandez asked the Rec Commission for their input on what ideas they want to see at the market.

Discussion ensued regarding the name change for the event and purchasing games and activities to include into the park since the structure of the event is not so much a farmer's market anymore. Cornhole tournament, pickleball tournament, weekly raffles, yard games and a photobooth with themed backdrops were suggested. Commissioner Mejia suggested Fowler Family Fun Night as an alternate name with a strong focus on food and family activities.

Coordinator Hernandez reported on the inquiry from Adventist Health to sponsor the first and last market event which would be moved to their property. Discussion ensued on this topic and Coordinator Hernandez stated that follow-up discussions would take place.

Councilman Mejia asked if the Market could be at Donny Wright Park at least once as well.

COMMISSIONER REPORTS AND COMMENTS

Chairman Jones asked for updates from the Commissioners. Commissioner Mejia requested that the vice chairman position be backfilled, trunk or treat and tree lighting events be added to the agenda for discussion.

Coordinator Hernandez asked the Commission to send her agenda requests from now on and asked if there are any items that need to be added to the next agenda. Chairman Jones requested the recap of 4^{th} of July event.
CITY COUNCIL LIAISON COMMENTS Chairman Jones asked Councilman Mejia for any updates or comments. Councilman Mejia had none to report.
OTHER MATTERS Chairman Jones reported that the next Recreation Commission meeting was scheduled for Tuesday, July 12, 2022.
ADJOURNMENT A motion was made by Commissioner Parker and seconded by Commissioner Mejia to adjourn the meeting which was concluded at 7:22pm.
