Pursuant of section 2-2.206 of the City of Fowler Code of Ordnances, the Recreation Commission shall hold meetings at least once each month, at a time and place set by resolution, and shall adopt rules for the conduct of business and shall instruct the secretary to keep accurate record of its minutes, resolutions, transactions, and other business. Such records shall be a public record and shall be maintained in the office of the City Clerk. All meetings shall be open to the public and shall abide by the provisions of the Ralph M. Brown Act. A majority of the Commission shall constitute a quorum for the conduct of business. (Ord. 78-1, 4-5-78)

Pursuant to the notice of meeting duly given, a meeting of the City of Fowler Recreation Commission was held on Tuesday, August 8, 2023, at 6:00 p.m. in person at the City of Fowler City Council Chambers located at 128 South 5<sup>th</sup> Street, Fowler, Ca. 93625.

#### 1. MEETING CALLED TO ORDER

#### 3. PUBLIC PRESENTATIONS

There were no public presentations in person or via teleconference, so this portion of the meeting was concluded.

#### 4. APPROVAL OF THE MINUTES

Vice Chairman Mejia directed the Commission's attention to the August 8, 2023, Recreation Commission Meeting minutes. There being no additions, and upon motion by Commissioner Velasquez-Lopez and second by Vice Chair Mejia, the following resolution was approved unanimously.

RESOLVED, that the Commission hereby approves the minutes of the August 8, 2023, City of Fowler Recreation Commission meeting.

#### 5. BUDGET

Recreation Department Supervisor: Yvonne Hernandez provided the commissioners with an itemized budget for the fiscal year listing the events sponsored by the Recreation Commission and the City of Fowler. A conversation arose regarding adding events to our calendar and the desire to increase the budget next year. City-wide clean-up was discussed, and the commission

decided to add the event once in the Spring and once in the Fall. The date for the fall clean-up is TBD.

#### 6. Workshop-Bike, Walk and Trails Plan (Toole Design)

Community and Economic Development Director: Thomas Gaffery briefed the commission about the information regarding the project. Tool Design gave a presentation outlining the Bike, walk, and trails plan. They indicated they'd be at Starbucks and other locations around town to gather feedback from residents and answer questions from the community on the project.

#### 7. 4th of July Recap

The event was an overall success, many commissioners received compliments about the fireworks show. Vendors were more controlled with the new "pass" policy that was implemented this year. The discussion continued with Commissioner Martinez discussing the issue of water not being allowed into the venue and the potential reasons to revise the policy. Commissioner Velasquez-Lopez agreed, and Chair Rico-Vasquez discussed areas of improvement. Commissioner Alatorre brought up a concern with the entrance gate being locked at the end of the evening as an exit after the event, a discussion ensued, and it was indicated that the gate was closed for traffic control.

#### 8. Wednesday Night at the Park (WNATP)

The Commission reviewed a flyer with themed nights through the end of WNATP. An open discussion developed, and we collectively praised the Polynesian group and the participation of the community. The commissioners were encouraged to come up with ideas to enhance the experience for the community.

#### 9. Trunk or Treat

A new entry/exit point was discussed, as well as the idea of having age limits, and "trick-or-treat" bags to eliminate people cutting in line.

#### 10. Christmas on Merced Street

The event will be held on December 6, 2023. We will ask Allen to join us, as well as The Grinch, Santa, pony rides, and the train. Snow will be back by popular demand.

#### 11. Children's Shopping Day

This event will be held on December 9. 2023. Conversation ensued with the Fire House being suggested as the new location to allow for more room. Also discussed was the idea of buying tents and having a wrapping station, cookies, beverages, and a waiting area for parents outside.

#### 12. Ambassador's Program Update

There was a great response to this program, and 12 seniors were signed up. They are currently helping with WNATP and will assist the recreation commission with future events.

#### 13. Movie night in the Park

This event will be pushed to February 2024. Vice Chair Mejia suggested we utilize the baseball field and show a baseball themed movie.

#### 14. Cook-Off

The commissioners agreed that combining a cook-off with an existing event would be more favorable.

#### 15. Commissioner Reports and Comments

Recreation Department Supervisor: Yvonne Hernandez asked the commissioners to repost WNATP flyers weekly on social media. Public Swim families requested an "end of season" party. The commissioners were receptive to the idea and discussed a movie and popcorn in addition to the swim party.
