

4. APPROVE a Resolution pertaining to Vesting Tentative Subdivision Map No. 6471 recommending that the City Council:
  - i. Adopt a Mitigated Negative Declaration pursuant to the California Environmental Quality Act (CEQA)

- ii. Prezone Vesting Tentative Subdivision Map No. 6471 to M-1 (Light Industrial) and its designated remainder to R-3 (Single-Family Residential)
- iii. Prezone APN 340-120-06 to R-3
- iv. Initiate annexation of Vesting Tentative Subdivision Map No. 6471 and APN 340-120-06
- v. Approve Vesting Tentative Subdivision Map No. 6471, once the Williamson Act contract has been tentatively cancelled by the County of Fresno
